Paid Firefighters may have the letter signed by their ranking or superior officer accompanied by their Fire Department Identification Card.*
5. All Moneys must be signed and submitted with the application and copy of current Motorcycle registration and mailed to the address listed above.
6. Please allow 4 weeks for processing
